1. GOALS AND OBJECTIVES

- 1.1. Popularization of MMA (Mixed Martial Arts) and TACTICAL WRESTLING (tactical combat), healthy lifestyle, upbringing feeling of patriotism and spirituality, prevention of crime and drug abuse.
- 1.2. Increasing the skills of athletes, strengthening the skills acquired during the training process.
- 1.3. Further training of judges and coaches.
- 1.4. Development and strengthening of relations between the international sports clubs and federations of martial arts in Europe, regional offices and clubs involved in promoting the arts and MMA (Mixed Martial Arts) and TACTICAL WRESTLING (tactical combat).
- 1.5. The formation of national teams to participate in international tournaments.

2. PLACE AND DATES

- 2.1. Location: Bulgaria, Albena resort town.
- 2.2. Dates: from 7th to 9th July 2015
- 2.3. Physical culture and sports events are held at the sports facilities that meet the requirements of the relevant regulations, operating on the territory of Bulgaria and to ensure public order and safety of participants and spectators
- 2.4. Rules of the event:
For the Russian team is planned arrival of participants from June 29 -_3-6 July 2015 with the period of stay 2 or 3 weeks for preliminary charges of participation in the Festival of Martial Arts «GOLDEN GATE BULGARIA», after which will be held joint workshops, training and workshops with coaches and athletes in Bulgaria, Russia and other countries. Children are encouraged to support their parents.

6 July 2015. - Registration, credentials committee, weighing.

7 July 2015. - Inauguration and preliminary fights.

8 July 2015. - Semi-final and final fights among juniors.

9 July 2015. - Galla-finals adult, shooting TV Bulgaria and Russia.

3. CONDITIONS OF PARTICIPATION

- 3.1. Each participant at the time of passing the credentials committee shall have the following documents:
 - Passport or other identity document with a photo athlete;
 - Qualification / Gradebook athlete (if available in the sports discipline);
 - Insurance against accidents at playing sports with insurance coverage "whole world" and "Sports activities", the sum insured is at least 50 000;
 - Medical insurance policy "Going abroad" for medical care on the territory of Bulgaria (issued when applying for a visa);
 - Medical admission to participate in competitions;
 - To participate in the competitions of athletes under the age of 18 years - the mandatory submission of a written parental consent;
 - Compulsory use of the girls on the chest protector in all age categories.
- 3.2. As part of the competition allowed the participation of athletes in different sections.
- 3.3. The costs associated with sending participants, referees, coaches and representatives (food, travel and accommodation) at the expense of sending organizations, sponsors or personal funds of the participants.
- 3.4. The Jury reserves the right not to allow the participant to compete in the party's non-compliance to the requirements of an athlete participating in the competition.

5. FORMAT OF THE TOURNAMENT

- 5.1. Open European Cup tactical combat (TACTICAL WRESTLING) by the rules «ADCC»:

Competitive mesh on the Olympic system (section TACTICAL WRESTLING) with the presentation of medals Martial Arts Festival «GOLDEN GATE BULGARIA»: martial arts 1-2 and 3rd place.

- 5.2. Tournament Mixed Martial Arts «TIME to FIGHT»:

Competitive mesh on the Olympic system (Section MMA-mixed martial arts with the presentation of medals Martial Arts Festival «GOLDEN GATE BULGARIA» for 1-2 and 3rd place.

In the final section of MMA SAFE (age group 8-17 years) in the weight category with the highest number of participants will be awarded the championship belt of the tournament «TIME to FIGHT JUNIOR».

In the final section of MMA (age group 18-35 years) in the weight category with the highest number of participants will be awarded a gold belt of the champion of the tournament «TIME to FIGHT».

BELT CHAMPIONS tournament «TIME to FIGHT» will be awarded for fully spent Finals defeat (failure) can be considered only in view of removing the finalists doctor.

- 5.3. Trust donation of 35 Euro uchastie-.

5.4. **Discipline MMA SAFE:** naked torso (rashgard optional), shorts, helmet (closed type), protection and shin instep, groin, without caps, gloves for mixed martial arts. Allow full contact striking and throwing the correct equipment in the rack and orchestra (the agreed at the meeting (seminar) judges and representatives).

In the discipline of MMA SAFE LITE VERSION age category «KIDS» (8-11 years) shock techniques in the stalls is prohibited. Fights take place in the Octagon (Octagon), the ring mat.

Fight lasts:

Age 8-11 years - 2 rounds of 1.5 minutes with a break of 1 minute

Ages 12-17 - 2 rounds of 2 minutes with a break of 1 minute

Age 18-35 years - 2 rounds of 3 minutes with a break of 1 minute

Finals age 18-35 years - 2 rounds of 4 minutes with a break of 1 minute.

Allowed Extra round.

- 5.5. **Discipline TACTICAL WRESTLING:** shorts for mixed martial arts, rashgard, groin, (cap and headphones optional). Resolve any correct throwing technique, on the ground allowed painful and suffocating receptions. It is forbidden to use any ointments and creams warming up.
- 5.6. To participate in the competition organizers will provide technical equipment on a partner: the company GREEN HILL.
- 5.7. Filing a protest to the Appeal Committee are exercised by the team no later than 30 minutes after the occurrence of a disputable situation with reference to the specific paragraph of the Rules and the provision of technical videos. The composition of the Jury of Appeal consists of the Chief Judge of the competition (or his deputy), Senior site. The decision of the Jury of Appeal is final. The fee for appeal - 100 Euro. Appeal fee on appeal, is not returned. The decision on disqualification is taken by the main judge of competition, together with the members of the Jury of Appeal on the proposal older platforms.
- 5.8. **Preliminary applications with data passports (the representatives of the Russian Federation) to participate in the tournament must necessarily be declared by e-mail: ttf-mr@mail.ru until 15 June 2015.**
